Dear East End Community Members,

East End United Community Center (EEUCC) experienced major growth in 2022. The 47th year since the inception of East End United Community Center saw us land a 21st CCLC Cohort 11 out-of-school time grant for \$499,999 per year over the course of five years in August. This grant expanded our budget and provided us with more resources to serve the community and county going forward. And, as always, the amazing hard work and generosity of our staff, board members, volunteers, donors, participants, and partners made it possible.

In 2022 EEUCC's Little Legends Daycare tripled in size allowing us to focus on elevating from a STARS 2 to a STARS 4 rating in 2023, and to eye up a Pennsylvania Pre-K Counts grant that would provide free preschool to children in our community in 2024. Funding from the Staunton Farm Foundation laid the groundwork for a Helping Vets program designed to help veterans dealing with grief, and a grant from the United Way of Southwestern Pennsylvania led to English as a Second Language classes. While our core programming and services including truancy mitigation, monthly food pantry, free diapers, and community gardening continued to be refined, it was great to reach new groups of people in our community.

Throughout 2022 our board discussed whether to expand our building. By the end of 2022 it was clear that building expansion was necessary. Steps were taken, and we will have 450 feet of extra office space, and 468-foot addition to our Pre-K Daycare Room completed by May 2024. Because of our growth in 2022, we have simply run out of space for employees, children, and community members.

We also bolstered our staff in 2022, adding a full time administrative assistant, office assistant, and 21st CCLC Program Director. A decision was also made to outsource our financial management to Jeff McCue's accounting firm, and that has made EEUCC more efficient.

As you will read in the following pages, there are a lot of good things that happen at East End. The stories in this report will outline some of the ways East End positively impacts the local community and shed some light on how we will continue to make a difference.

The efforts of all East End community members have allowed us continued growth and success, and for that I am grateful. Thank you all for all that you do!

Program Spotlight



EAST END UNITED COMMUNITY CENTER WAS AWARDED 21ST CCLC FUNDING!

In August 2022, EEUCC secured a \$499,999 annual grant for the next five years through 21st CCLC Cohort 11 funding. This grant will support out-of-school time services for students, focusing on academic enrichment during non-school hours. The program targets students in grades 1-5 at Benjamin Franklin, Lafayette, and Waynesburg Central elementary schools. Afterschool sessions are from Monday to Thursday, 3pm-5:30pm for Uniontown area schools and 3:15pm-5:45pm for Central Greene students at Waynesburg Central Elementary School. The program aligns with state academic standards and offers a five-week summer school from mid-June to late-July, along with hot meals provided through the Child and Adult Food Care Program and Summer Food Service Program. Collaborations with Uniontown Area School District and Central Greene School District enhance the program's success. EEUCC's longstanding partnership with these districts and our mission to provide educational and community opportunities will be amplified through this grant.

EEUCC Diaper Bank



EEUCC's partnership with the Western Pennsylvania Diaper Bank (WPDB) has exemplified their unwavering commitment to the well-being of the community's most vulnerable members. By collaborating with WPDB, EEUCC has taken significant strides towards ensuring that infants in need experience the fundamental comfort of being clean, healthy, and dry. In the year 2022 alone, EEUCC's efforts reached an astounding 187 families, providing them with essential diaper bank supplies including diapers, pull ups, wipes, baby shampoo, baby lotion, and even feminine products. This partnership stands as a poignant reminder of EEUCC's dedication to fostering holistic support systems, as we not only address immediate needs but also strive to empower families for a better future.

Goodwill Give Back



EEUCC's collaboration with Goodwill's "Give Back Program" underscores our commitment to creating meaningful impact in the lives of those facing challenges. Through this partnership, EEUCC has extended a helping hand to families in need by providing them with \$25 Goodwill gift cards per family member, with a limit of 4 family members. In the year 2022, this initiative reached new heights as EEUCC distributed a remarkable total of 200 gift cards, demonstrating our dedication to making a tangible difference in the community. By offering access to essential goods and resources through the Goodwill gift cards, EEUCC continues to exemplify its mission of nurturing well-being and creating a sense of belonging among those we serve.

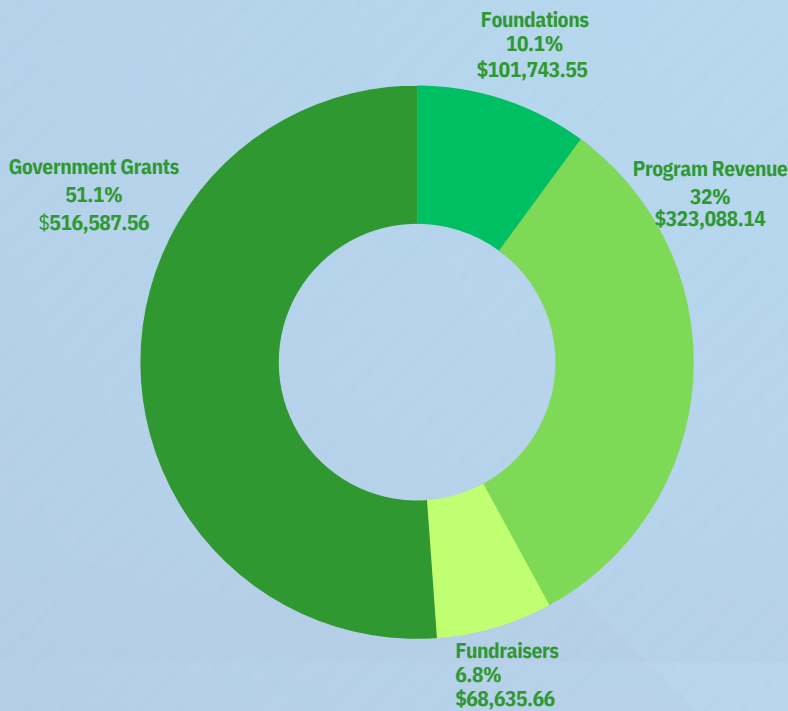

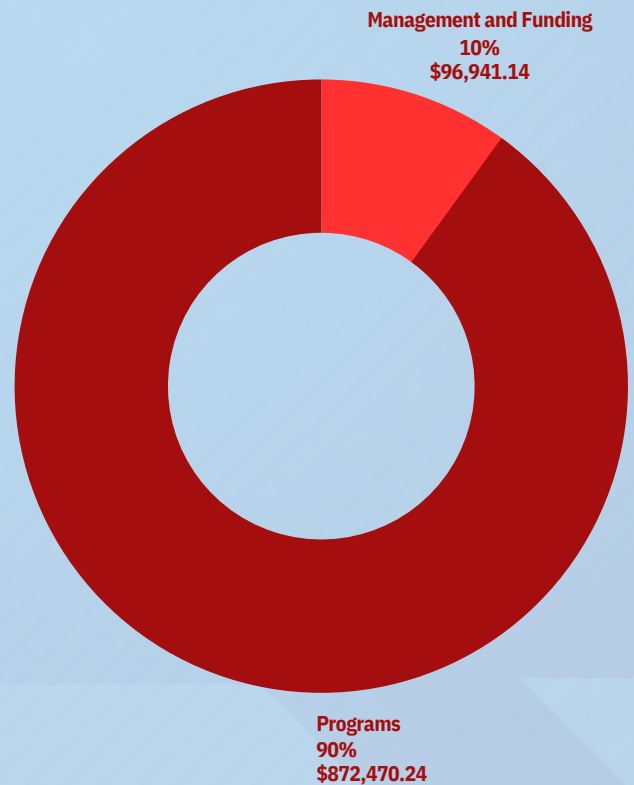
